# MINUTES OF MEETING HELD AT LLANFYNYDD SCHOOL, ON TUESDAY, 9<sup>th</sup> JULY 2013, AT 8:00 PM.

**13/13: PRESENT:** Cllrs. David Jones, Mairwen Rees, Brian Thomas, Haydn Jones, Lee Strudwick, & Rod Morgan, and County Cllr. Mansel Charles.

Also present: Sgt Louise Lewis.

#### 12/13: APOLOGIES RECEIVED FROM

Cllr. Dewi George, and Cllr. Merion Jones. Cllr David Jones Chaired the meeting in the Chairman's absence.

#### 13/13: THE CHAIRMAN WELCOMED ALL PRESENT.

Before the meeting commenced, the Chair invited Sgt Lewis to speak.

#### 14/13: LOCAL CRIME REPORT.

Sgt Lewis noted that it had been a quiet month. It is thought that "Cuppa with a Copper" will be held in the church, following the warden's offer to hold the event, it was also noted that Val Martin had invited the police officers to drop in on the regular coffee mornings at the Penybont Inn.

The Chair offered to confirm this with the clerk, in order that she may e-mail Sgt Lewis.

Regarding the recent arrests made in connection with the illegal growing of cannabis, Sgt Lewis noted that leads are being followed, and that it could take up to three weeks before there is any further news.

The OWL forms were completed by the clerk and other councillors, and will be actioned shortly.

It was noted that the Llandeilo Jazz Festival was successful, and that the Llanfynydd Agricultural Show will take place on August 10<sup>th</sup>.

# **15/13: ACCEPTANCE OF THE JUNE MINUTES.** The following corrections were made to the June minutes:

These were amended by hand, following which, Cllr David Jones proposed that they be accepted. Cllr. Brian Thomas seconded the proposal. The minutes were accepted, and the Chair signed two copies. One copy was placed in the notice board.

#### 16/13: MATTERS ARISING

a.72/07: a The Hall Plot. A second bench is still required, with a plaque noting the contribution to the project made by the publication of "the History of Llanfynydd" It was noted that there is a good quality soft wood bench available from LBS for approximately £300. A hardwood bench would be approximately £400. It was agreed that the Chair and the Clerk would attend the shop and purchase the bench from the History Account. It was also resolved to purchase a table and bench unit from recycled plastic.

accepted and a cheque prepared accordingly from the History of Llanfynydd account.

It was noted that the wild and meadow seeded area of the plot is significantly different in appearance to the lawn seeded area. It will soon be possible to mow the plot.

- b. <u>49/12:b Telephone & Electricity Poles.</u> No reply has yet been received from BT. the clerk is to write to Open Reach to request advice as to whether the telephone box may be painted; if necessary Cllr. Rod Morgan will undertake to do the work himself.
- c. Western Power Distribution: Power cuts & improving the electricity network and Brechfa Forest Connection Project Consultation There are four proposed routes which will join up at Llandyfaelog, the pylons would carry the energy from the wind farm that has already been granted and the possible two others that are being considered. There is also a suggestion that the cables could be buried. Cllr Rod Morgan asked if it was possible to support the proposal to bury the lines, and the council resolved that the clerk would write to CCC accordingly. C. Cllr Mansel Charles also supports burying of the cables. A public meeting is due to be held at Pontargothi on August1st, to seek local views.

There was a perception that local opinion was often ignored. The council was largely confident about which organisations provided which services, and that access to those facilities was easily available. The clerk is to write to the Commission accordingly.

- b. <u>BDO Stoy Hayward: Audit Emma Price</u> wrote noting there were no issues arising to consider prior to the council's approval. She also noted her intention to issue an unqualified certificate. The Chair and clerk signed the document accordingly. The clerk is to return the certified audit to BDO before 15<sup>th</sup> July.

If it becomes too overwhelming he will advise the council in January, which would give sufficient time to appoint an alternative Vice-Chair who would then be able to take on the Chairs role in due course. Cllr Lee Strudwick was happy to support him in this.
