178/14: CHAIRMANS WELCOME – As both the chair and vice-chair were unable to attend this meeting, it was proposed by Cllr. Haydn Jones and seconded by Cllr. Brian Thomas that Cllr. Mairwen Rees should take the chair. Cllr. Rees accepted and welcomed everyone present & congratulated Llanfynydd Young Farmers on coming 4th in the YFC Eisteddfod.

180/14: MINUTES

183/14: COMMUNITY SPACE STEERING GROUP

- a. Imminent Closure of Llanfynydd School An email from County Cllr. Mansel Charles was read out suggesting that all groups in the village write to the Revd. Cannon Bryan Witt stating the urgent need for a community space in the Llanfynydd village. It was agreed that the clerk would write a letter on behalf of the Community Council pointing out the need for a community building for organisations to use.
- b. 171/14a: The results of the questionnaire were presented. It was noted that 99% support the "Community Space Project", 97% indicated the most suitable venues are a, The "Penybont" Building b, The school Building c, A new building on the Sharing Plot and d, 3% other alternatives. The conclusion of the questionnaire: "The questionnaire has clearly demonstrated the need to revitalize a Sense of Pride and Community Spirit within Llanfynydd, by the support for obtaining a local village venue with amenities, social activities, entertainment opportunities including keep-fit/wellbeing and education/information all of which with enthusiastic united support and funding can be achieved."

c. Cllr. Meirion Jones informed the council that the next step is to apply for the grant to get professional people in to arrange the survey and feasibility study.

 d. 170/14c: It was noted that a copy of the Late Rev. David Jones Will was forwarded to Claire Papworth as requested.

184/14: HALL PLOT/COMMUNITY GARDEN

a. 171/14b, Cllr. Brian Thomas has strimmed the plot.

b. 171/14c, Items held at school –The clerk has been informed that the items being donated to the council
have been placed in the blue shed until further notice.

c. 171/14d: Insurance - An email in the form of a letter was received from Helen Sargent & Chris

Papworth stating "that even though this matter has been addressed previously they feel that there has been no satisfactory resolution for the community". They stated that they had been in contact with the council's insurers Zurich and attached an extract from a OVW publication "Benefits of a Community or Town Council". In the letter it was stated that insurance cover can be provided under the current Zurich policy by following a procedure of accepting a written proposal from a club or organisation or sponsoring an event by letter or by including it in the minutes of the meeting.

In response to this letter, the clerk read out an email from Zurich confirming that on their records they did in fact speak with Claire Papworth from the Village Society and that "the village society are a separate organisation and would need to have it's own insurance for events". It was noted that Zurich should not have under any circumstances spoken with a member of the public regarding the councils insurance policy, but in the email it was clarified that "Louise Bolton spoke to Claire from the society but did not talk about the council's policy in detail". It was decided that the clerk would write to the LVS again stating that the insurance policy will not cover events that are not organised by the council.

185/14: ROAD MAINTENANCE

- a. 172/14a: Overhanging trees between Y Mans and Sgwar Pantycelyn, Capel Isaac & Pantycelyn Sq to Y Rheol and onto Crachdy Isaf farm It was noted that the work had been completed but from Pantycelyn Sq to Y Rheol work remained outstanding.
- b. 172/14g: Street Lighting by Ty Newydd & Ael Y Bryn The Councillors did visit the site after the last meeting. It was noted that the lighting had improved since the trees had been cut back, but it was agreed that the clerk get an estimate for new lighting from CCC.
- c. 172d/14: Overhanging trees & Subsidence at Pantmawr, Llanfynydd, and along the Llanfynydd to Abergorlech road (Pantgwyrdd, past Panthowell on the left) – It was noted that no work has been done. The clerk is to follow up.
- d. 172/14h, Dog Foul Steve Raymond from CCC environmental has paid a visit to the village & put up extra signs, but stated that they found little evidence of dog faeces. He asked if specific areas could be identified. Councillors agreed to update the clerk accordingly.
- e. 172/14i: Speed Limit A site visit has been arranged to discuss where the counter locations will be placed, on 21st November, with John Mc Evoy & available councillors. The clerk is to contact Cllr. David Jones to see if he'll be available.
- f. 172/14k:Street lighting in the village It was noted that Chairman Cllr. Lee Strudwick is yet to get the lighting numbers & email to County Cllr. Mansel Charles & the clerk so they can follow it up. It was also noted that the LED light by the Farmers wasn't giving off much light. Cllr. Law agreed to speak to the owner of an overhanging tree which may be obscuring the light.

186/14: PLANNING

- a. 16/10/14 E/31009 Application for cert of Lawfulness Existing. Retain dwelling (lived in 12 years), Barn (10years), Caravan (11 years sometimes stayed in) on site. Land adj Penlan Fach, Llanfynydd, Mrs Susan Hollins.
 - Permission granted on 28/10/14. It was noted that normal planning procedure was not followed in this instance as the planning was granted within 12 days and the council were not given the usual 21 days to respond. It was decided that the clerk write to the planning dept. stating this and also that their decision to grant planning on this occasion may open the floodgates to numerous similar future applications in the parish. The council also wished to be notified of any other developments at this location that may require potential planning permission.
- b. 173/14a:APP1120/E28808 Mrs Susan Hollins, land adj Penlan Fach, Tipi Valley, Llanfynydd. It was noted that this enquiry has been withdrawn.
- Planning Application E/30713 Mr. Clint Morgan, 1 Heol Newydd, Llanfynydd. Single Storey rear extension. Permission Granted.

187/14: GRANT AID

- a. A List of grant aid applicants was presented to the council. Grant Aid was awarded to Carmarthen Federation of YFC, The LVS and Community Space Steering Group combined and Abergorlech Eisteddfod. Three cheques of £50 each were prepared and signed. Cllr. Merion Jones declared an interest in the LVS and Steering Group.
- b. Maud Watkins The 20I3 list was presented and updated. There are now 27 recipients of £15 and 2 of £50. The clerk is to prepare a letter for the bank for £505 and get it signed by all councillors and present it to the bank for the funds. The clerk will bring the awards to the next meeting.

188/14: FINANCE

- a. 160d/14: Annual Audit The clerk noted that Mrs. Claire Papworth had requested a copy of the BDO financial statement and had forwarded on a copy as requested.
- b. 175/14c: History of Llanfynydd It was noted that the bank accepted the cheque of £25.
- 175/14d: Clerks Salary A cheque was prepared & signed for the extra meeting in July as previously agreed.
- d. Revenue Penalty Notice The clerk noted that the council had received a penalty notice for £400 for not making an end of year return for 2013/2014. After a lengthy call with the revenue the clerk noted that the penalty was issued in error as the previous clerk was not a real time employee & therefore did not have to submit the said return. The clerk submitted a return of no employee payments on line which therefore cancelled the penalty.
- Poppy Appeal Organiser An invoice was presented for £20 for a wreath. It was agreed that a cheque for £30 be prepared & signed.

189/14: ANY OTHER BUSINESS

- a. 176/14a: County Bogs project sign The clerk stated that she has contacted Rosie Carmichael but is yet awaiting a response.
- b. 176/14c: Broadband Cllr. Peter Law had sent an email informing the council that there has been an
 update on the web page for super fast fibre roll out for Dryslwyn and Brechfa exchanges, they will be
 upgraded starting September 2015.
- 176/14f: It was noted that Councillor Lee Strudwick had cut back the ever green trees around the war memorial in the village.
- d. It was noted that the school has no heating on at present. County Cllr. Charles is to follow this up.
- e. It was discussed that with Christmas fast approaching, the annual council dinner should be organised. The clerk is to get menus from Pant Glas & New Cross Inn.
- f. Cllr. Mairwen Rees, who was acting chairman, closed the meeting at 9.25pm for ten minutes and invited the members of the public for their comments. The attached points were raised at this time.

- Hall Plot It was confirmed that Helen Sargent had weeded the flower beds and that it would benefit from receiving mulch. Cllr. Law to contact Cllr. Morgan
- Japanese Knotweed Cllr. Peter Law is to print out hand outs & put up information on how to deal with the knotweed problem as previously agreed.
- ➤ Insurance It was confirmed that although Mrs. Papworth had previously spoken to the council's insurance company, Zurich, a more recent conversation was held between Mr. Papworth and Zurich. Mrs. Papworth stated she would like to see the Council support events so that the LVS don't have the expense of paying for extra insurance.
- Community Space It was confirmed that the Steering Group was writing to local organisations in order to ask where and when they met, what activities they carried out. It was said that the village lacked community spirit and that organisations should work together in order to achieve the goal of a community space.
- Questionnaire The results of the Bar chart were read out. Mrs. Papworth informed the council that copies had been given to Cllr. Lee Strudwick to pass on at the meeting, but as Cllr. Strudwick was not present, this had not happened.
