36 /16: PRESENT: Chairman Meirion Jones, Cllrs Brian Thomas, Mairwen Rees, Dylan Thomas, Lee Strudwick and Haydn Jones

37 /16 CHAIRMANS WELCOME – The chairman welcomed everyone present to the September meeting, and extended the Councils sympathy to Mr. Cliff Price and his family following their recent bereavement. The Councils congratulations were extended to Elgan Thomas following his recent marriage.

39 /16: DECLARATIONS OF PERSONAL INTEREST – County Cllr. Mansel Charles declared an interest in any planning issues that will arise.

40 /16 CONTRIBUTIONS FROM THE PUBLIC – It was noted that funds in the region of £212.90 have been raised by villagers and the Penybont Inn, these funds will go towards the cost of a defibrillator for the Community. The Chairman also expressed his thanks for the fundraising and the prizes generously given.

# 42/16: MATTERS ARISING FROM THE MINUTES

- a. 45/16a the Gazebo has been returned to the village, but it has been damaged and needs repairing. Quotation for repair was accepted and Councillors have agreed to meet over the coming weeks to prepare a base for the gazebo.
- b. 9/16a: Right of Way opposite Meadow View To be reviewed.
- c. 9/16b: Pot holes at Bryn yr Eglwys some of these potholes have been filled, but as this section of road Will be used by forestry traffic in the coming months, they will become responsible for its maintenance And the Forestry Commission on the completion of their use will make the road good.
- d. 9/15h Sign Posts either side of the road at Llwyncelyn Farm Yard It was noted that Cllr. Meirion Jones had Met with John Mc Evoy. The request has been placed on the CCC list for signs. It was noted that the farm Owner has asked that the sat Nav co-ordinates for the area be redirected. Mr. McEvoy is to follow this up
- e. 49/16/sign leading to Brynberlian through Maes yr Haidd It was noted that the No through Road sign had Been taken down, as the Welsh spelling was incorrect. It has been agreed that the sign is to be replaced. It was requested that the clerk contact CCC regarding the possibility of "no Sat Nav "signage"
