Minutes of the meeting of Llanfynydd Community Council held at 7,30pm on Monday, 5th January 2015 at Llanfynydd School.

It was proposed by Cllr. Mairwen Rees and seconded by Cllr. Haydn Jones that the minutes of the meeting held on 1st December 2014 be accepted as a correct record of proceedings.

5/15: MATTERS ARISING FROM THE MINUTES

- a. 194/14a JAPANESE KNOTWEED Cllr. Peter Law advised at the previous meeting that due to precommitments that he has yet to distribute the information leaflets on dealing with the knotweed problem. To be discussed at next meeting.
- b. A copy of a letter from Minister Carl Sargeant to MP Jonathan Edwards was read out, highlighting constituents concerns about problematic Japanese knotweed in Carmarthenshire. This letter stated that present due to the extent of the knotweed distribution it now makes it financially impractical to eradicate using current control techniques, so novel control methods are currently being investigated. The Welsh government is currently supporting two such projects. As suggested in the letter, it was decided that the clerk write to Natural Resources Wales to inquire whether they have a current control programme on that particular river basin or if not, whether there is one planned for the future.

7/15: COMMUNITY SPACE STEERING GROUP

- a. 197/14c. It was noted that the end of year financial accounts for the LVS & Steering group would be available in May.
- b. The council was informed that the steering group had put in their 1st stage application to the National Lottery Grant, which is for a feasibility study.

8/15: HALL PLOT/COMMUNITY GARDEN

- a. 198/14a, Items held at school -It was noted that the items still remain in the school shed and would do
 till end of March. It was also noted that the council still haven't received any confirmation as to the
 future of the school. To be reviewed.
- b. It was suggested that a shed may be needed in the Hall Plot to store the items.
- c. It was noted that since the closure of the school that Mrs. Julie Jones had been maintaining the community Garden.
- d. A letter had been received from the LVS asking the council to consider adopting a small contracts tender system to maintain community assets such as the Hall Plot, School Garden, Flower Troughs, Benches, Sign Boards, Gates & Fencing. It was discussed, considered & then decided that the current system of people volunteering to do these acts of maintenance was working at present and would continue to give community members a sense of pride and enhance community spirit in the village. It was also noted that the grant received for the development of the Hall Plot stated that one of the conditions of the grant was that the community be involved in maintaining it. It was mentioned that maybe a sub-committee could be set up in order to organise the upkeep of the village. The council stated it was grateful to the LVS and other individuals for the hard work & help in maintaining the village.

9/15: ROAD MAINTENANCE

a. 199/14a: Overhanging trees from Pantycelyn Sq., Capel Isaac, to Y Rheol. It was noted that the wor

- b. 199/14b: Street Lighting by Ty Newydd & Ael Y Bryn The topic of getting an extra light installed was discussed again. A vote was taken by the Councillors & it was decided not to apply for the additional lighting at present. It was decided that the clerk contact Nigel Francis to enquire as to whether it would be this financial year or next year that the cost of lighting, if required, would occur as it had not been factored in this years precept.
 - Cllr. Peter Law stated at the previous meeting that he had contacted the council with the street lamp numbers that were giving trouble in the village. It was suggested that the clerk be included in any correspondence to CCC re street lighting. Cllr. Law also stated that he had not contacted the owner of the overhanging tree which is obscuring the light as the light isn't working at present, but agreed to do so when the light is working again. To be reviewed at next meeting.
 - It was noted that most of the lights in the village have a problem. Some now are on all night & the light opposite the Pen Y Bont is not working at all. The clerk is to contact CCC & request Street Light survey.
