9/16: ROAD MAINTENANCE

- a. 190/15a: Right of Way opposite Meadow View To be reviewed.
- b. 190/15b: Pot holes at Bryn yr Eglwys It was noted CCC have arranged a job sheet for a permanent repair. To be reviewed.

It was noted that Mr. John Mc Evoy would be in the area on 02/02/16, it was agreed that the clerk would contact him to request two farm signs either side of the road at Llwyncelyn Farm Yard. Cllrs.
