Road Maintenance and footbridges.

- 1) **Clawddown With** reference to the e-mail below from Llanfynydd Community Council, the structure has since been inspected and relates to a PROW footbridge – refer attached photographs for reference. As can be seen the footbridge has collapsed and needs to be closed to pedestrians until such time that it can be replaced.
- 2) **Bridge at Abersannan** Further to your e-mail, the bridge at Abersannan has been inspected and the defects noted. A work order has been issued to the Assistant Area Manager to address the defects and the works will be undertaken in due course. Due to current work commitments, it is not possible to advise of a start date at the present time.
- 3) **Tree Cwmsannan** I am assuming this was the one reported some time ago and is the one on the bank between the 2 properties in question.
FYI we have contacted the landowner who is responsible and checked the tree, it is firmly wedged on the bank and is unlikely to fall into the road, if it should the landowner knows he will be held responsible.
- 4) **Old Farmers Arms** all parties agreed that the sign post (and direction sign plates) could be re-located to the point indicated on the attached plans - offset 450mm, in close proximity to a steel chamber. There would be a requirement to cut back vegetation around a fence post. The proprietor of the Farmers Arms P/H was satisfied with this
