003/18: Chairman's welcome - The Chairman welcomed all present to the June meeting.

PCSO Kerr gave an update on recent incidents within the Parish. Following the thefts of Quad bikes, some have been recovered. He had visited the site of the recent rave in Brechfa Forest, and noted that some attendees had remained to clear the site of rubbish.

CC Charles updated Councillors on the recent thefts of small implements and diesel within the area.

004/18: Declarations of personal interest

005/18: Contributions from the public. No members of the public were in attendance.

006/18: To confirm the Minutes of the previous meeting

The Chairman as true reflection of the meetings duly signed the minutes of the meeting held on 8th May 2018.

- 1) Revised LDP 2019-2033. The new closure date is now 2pm on the 29th of August 2018 for sites to be LDP workshop planned for the 30th July at The Civic Hall Llandello. 5pm start
- 2) CCC: Memorandum of understanding Child burial fees. The purpose of the MOU is that Burial Authorities in Wales will not charge any fees in relation to the standard burial or cremation of a child, defined for these purposes as a person under the age of 18. This commitment applies to standard fees that burial authorities charge relating to:
 - The cremation of a person under 18 (including stillborn and foetal remains)
 - The internment of a person under 18 (including stillborn and foetal remains)
 - The exclusive Right of Burial where required.
 - Any other fee directly relating to the burial or cremation of a person under the age of 18 years (for example, the fees charged for the permission to erect a memorial)
- 3) Hywel Dda Health Board, notification of the next round of drop in events.

6) 2018 standing orders: these will be used as guidelines. A discussion took place regarding the need for a Data Protection Officer and it was agreed that the role becomes part of the Chairman's duties

009/18: ROAD MAINTENANCE

Councillor Meirion Jones had met with representatives of Carmarthenshire County Council to discuss reported road maintenance issues.

Below is a list of already reported issues.

- 1) 91/16/b the green road between Maesyrhaidd and Brynberllan near the river is now inaccessible for Walkers and vehicles. CCC has now agreed that this should be classified as a Through Route.
- Subsidence near Brisgen Isaf on the U4431. 2)
- Potholes between Llwyn celyn and Pantyrefail U4433

- 5) The area around Brynberllan needs attention, with issues with potholes, stones on the road, and ditches No updates needing clearing.

- 11) 16/b: Potholes at Bryn yr Eglwys the Forestry Commission has filled some of these potholes. On Completion of their prolonged use of this section of road, an inspection will take place and any remedial work completed by the Forestry Commission.
