- 1) Subsidence near Brisgen Isaf on the U4431. Reply received Deteriorated Carriageway Surface Recorded During Routine Inspections To Be Patched When Labour and Budget Allow
- 2) Potholes between Llwyn celyn and Pantyrefail U4433 reply received Potholes Previously Filled Highway Inspector / Mobile Crew to Monitor Further and Potholes to Be Filled as Ant When Required

- 3) Llys y nant, uneven road surface. Some repairs have taken place however the depressions are aiready appearing

Hopefully this will eliminate any water ponding on the carriageway. This work is subject to labour becoming available. Some work has been done but the problem has not been resolved
