## 038/19: To confirm the minutes of the previous meeting.

The Minutes of the meeting held on July 9<sup>th</sup> 2019 were signed off as a true account of the meeting.

#### 039/19 Matters arising.

**33/19/02:** Gas Cylinders within Valley View. Reply received from CCC I would confirm that the property was visited by an officer of this team back in April 2018, to undertake a risk assessment. Due to the number of empty properties that we have in this County, each property is risk assessed utilising a standard toolkit, with any action taken by the Local Authority being proportional to the level of risk.

This property was assessed in December 2016 at a Band C level of risk, which is our lowest level of risk. The property was equally risk assessed at a Band C in April 2018. We have traced the owner, and a letter was sent to offer a wide variety of advice, assistance and support. We also requested that the Owner contact the Council, to discuss plans to bring this property back into use. Regrettably, we did not receive a reply.

I understand from the attending officer, that the site looked unsightly from the roadside. This matter was referred to the Planning Enforcement Team under ref: E/ENF/07999,

(Untidy Land) back in January 2017. We are currently unaware what, if any action was taken by planning colleagues at this time.

Regrettably, within Housing we have limited delegation, and deal with matters under the Housing Act 2004 and Environmental Protection Act 1990. From the information sought from the last inspection, there are no factors that would warrant enforcement action by this Team. I will however arrange for a follow up inspection and risk assessment, and look to continue to offer support to the Owner with advice, guidance, financial assistance etc. with a view of bringing this property back into use.
