81/19/4 Clerk had spoken to a representative of the family who had previously donated the bench, near the war memorial, and they are happy for a safety assessment to take place, and if needs be, they are willing for the Community Council to remove the bench if it can not be repaired.

- 3) pothole at Pantglas / Pengoytre reply; the pothole has been recorded during routine inspections and will be filled by the mobile gang tomorrow (20th November), furthermore permanent patching is required and will be carried out when finances and labour become available
- 4) reply received re PantMawr, Llanfynydd: I received a report of this Highway support issue back on the 12th of September from Sion Lewis Highway Inspector. I have since instructed one of the Bridge Inspectors to go out and carry out an initial inspection of the reported defect and he has reported back his findings. Having looked at the photos I have instructed the Inspector to issue a work instruction to the area office to rectify the existing defective verge that affords support to the classified road number C2053

I would advise that a Works Instruction was issued to the area maintenance team on 15th October and that work has been programmed for end of December or sooner if the construction gang becomes available. Remedial works will included reinforcement mesh in the road and carriageway reconstruction together remedial works to the verge area.
